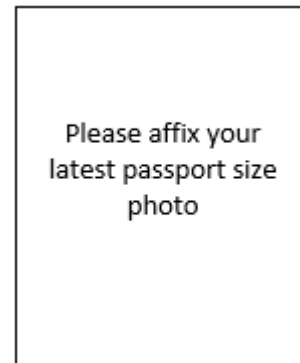

- 5) A Member standing for election as an officer must have previously served at least one complete term as an Officer or a Committee Member. The term may have occurred at any time prior to the Member's standing for election. A Member standing for election as a President must have previously served at least one complete term as an Officer and one complete term as a Committee Member. The term may have occurred at any time prior to the Member's standing for election.
- 6) A Member nominated to the Executive Committee is not eligible for nomination to the Board of Trustee.
- 7) Please quote your PMI ID and bring along a photo ID with you for the AGM.
- 8) Any violation of the above renders the Nomination Null and Void.
